In Richburg, South Carolina Please be advised that DHEC has made a decision regarding the permit after consideration and complete review of the following: the permit application, applicable state and federal air quality regulations, comments made at the public hearing held on March 13, 2014, all comments received within the required time frame, the public hearing transcripts, and all other pertinent information. All written comments received were reviewed for technical merit and have been included in DHEC's permanent record for this facility. DHEC has concluded that the issues raised and comments made by concerned citizens do not legally prevent issuance of the permit. Additionally, because Jones-Hamilton has demonstrated that it can comply with state and federal air quality regulations, DHEC is required by law to issue the requested permit.
