Analysis: During the reporting period, Solid Waste Enforcement entered into two Consent Orders, one with Medina's Hauling, Inc. and one with Harold C. Blackwell. Medina's Hauling Inc., disposed of concrete and land-clearing debris on the property of Harold C. Blackwell to fill two ravines. Mr. Blackwell's property is not registered as a structural fill or permitted to receive waste. Therefore, Mr. Blackwell allowed the open dumping of the material on his property by Medina's Hauling, Inc. To comply with the Orders, Mr. Blackwell must allow Medina's Hauling, Inc. entry onto his property to remove the concrete and land-clearing debris, properly dispose of it and submit disposal receipts. Medina's Hauling, Inc. was assessed a civil penalty in the amount of two thousand five hundred dollars (\$2,500.00) and Harold C. Blackwell was assessed a suspended penalty in the amount of six thousand dollars (\$6,000.00) should he fail to comply with any requirement of the Order.

Air Quality Enforcement entered into six (6) Consent Orders during the reporting period. Of those 6, three (3) of the Orders were for open burning violations. Total assessed penalties for the open burning violations were assessed in the amount of eight thousand five hundred dollars (\$8,500.00).
