School Nurse Orientation Planning Document (Clinical Focus)

This document was developed by the SC School Nurse Program Advisory Committee to identify key topics that should be covered during an orientation for nurses entering school nursing practice. The table below includes suggested content to be covered at the school district level and at a state-level orientation. The state-level orientation supplements the orientation that school nurses should receive within their district. Attendance at the state-level orientation is not mandatory.
