PROCEEDINGS

2	HEARING OFFICER BLALOCK: All right. So hello and
3	welcome. The time is now actually 7:21 p.m. on
4	Thursday, November 30, 2023, and this public
5	hearing will now begin. My name is Juli Blalock,
6	and I will serve as the hearing officer tonight.
7	This public hearing is being held by the South
8	Carolina Department of Health and Environmental
9	Control hereafter referred to as DHEC. The purpose
10	of this hearing is to accept comments and
11	supporting information on the mine operating permit
12	application and draft air permits for the proposed
13	Saluda Quarry.
1.4	

14 Luck Stone Corporation has submitted 15 applications to DHEC to construct and operate this 16 granite mine at a site located on Double Bridges 17 Road near the intersection with Heather Lane in Saluda County, approximately five miles northwest 18 of Batesburg-Leesville, South Carolina. 19 The 20 permitting process at DHEC begins when an 21 application is received for one or more 22 environmental permits. During the permitting 23 process, an applicant must show that the proposed 24 operation can comply with state and federal 25 These regulations were developed to regulations.



1	ensure that human health and the environment are
2	protected. In addition to reviewing the
3	application, DHEC's role is to write and, if
4	issued, enforce permits that meet the requirements
5	of the regulations.
6	You also have a role in DHEC's permitting
7	process. Your comments are very important to us
8	and may provide DHEC staff with additional things
9	to consider when making final decisions regarding
10	the proposed quarry. Final decisions have not yet
11	been made and will not be made here tonight. The
12	purpose of this hearing is for you to provide
13	comments before final decisions are made. Comments
14	made tonight are being recorded and will be
15	included in a written transcript prepared by a
16	certified court reporter. DHEC welcomes and
17	encourages all comments made tonight, as well as
18	those submitted in writing through the end of the
19	public comment period on Friday, December 15, 2023.
20	DHEC has created a web page for convenient
21	access to information about the proposed quarry.
22	The web page address is
23	www.DHEC.SC.gov/LuckStoneSaluda. Presentations
24	from tonight's public meeting will be posted on the
25	web page prior to the end of the public comment

1 period. 2 If you have not already done so, I encourage 3 each of you to go to the sign-in table tonight or use the mailing list form on DHEC's Luck Stone 4 5 Saluda web page. This will let us know how to notify you of the final decisions regarding the 6 7 proposed quarry. 8 As you can see up here, we also have 9 information on how to provide those comments, and 10 again, we will all be here to answer any questions 11 specifically if you need this information later. 12 We will now move to our agenda and the order 13 in which we will proceed for this hearing. An 14 overview of the proposed quarry modification and 15 DHEC's mine permitting process has been provided by 16 Sarah Harris. Following Sarah's presentation, an overview of the draft air permit and DHEC's air 17 18 permitting process was provided by Mareesa 19 Singleton. A statement will be shared providing an 20 overview of this project as we begin the hearing. 21 Following the reading of the statement, I will 22 begin the public comment portion by calling on 23 those of you who indicated during preregistration 24 that you would like to make a comment. If you have 25 decided that you no longer wish to speak when you

1	are called on, you may decline at that time. Once
2	we have finished hearing from all preregistered
3	speakers, those who did not preregister to speak
4	will be given an opportunity to make their
5	comments. At that time, I will give instructions
6	on how to indicate that you would like to make a
7	comment. After all comments have been heard, I
8	will make closing remarks and this public hearing
9	will be adjourned.
10	In order for everyone to have a fair and equal
11	opportunity to participate tonight and to ensure
12	that we proceed in a timely and effective manner,
13	the following four guidelines have been
14	established. First, there will be no questions or
15	answers during or after a presentation or comment.
16	Second, your comments should not go over three
17	minutes each. At the end of your allotted time, I
18	will interrupt to encourage you to conclude your
19	comments at that time. If you are not able to
20	complete your comments within the allotted time,
21	you are still able to submit written comments
22	before the end of the public comment period.
23	Please keep in mind that final decisions are not
24	made based on vote or how many people say the same
25	thing. Third, please be respectful towards all who

1	are presenting information or making comments here
2	tonight. You each have a unique and valued
3	perspective. No one comment is considered more
4	important than another. And, fourth, please do not
5	interrupt or ask other participants to respond
6	during your comments. Comments or actions that
7	distract from the purpose of this hearing will not
8	be allowed.
9	I will now call on Sarah Harris to present the
10	statement for this proposed project.
11	MS. HARRIS: On August 17, 2023, Luck Stone Corporation
12	submitted a mine operating permit application to
13	mine granite in Saluda County. Total permitted
14	area will be 331 acres with 284.1 acres affected
15	and 46.9 acres of buffer.
16	HEARING OFFICER BLALOCK: Thank you, Sarah. As we
17	transition into the comment portion oh, sorry.
18	I'm supposed to give it over to you, Mareesa.
19	MS. SINGLETON: Luck Stone Corporation Luck Saluda has
20	applied to the department for an air construction
21	permit to install and operate a new aggregate mine
22	and processing plant. A draft permit and draft
23	statement of basis have been written outlining the
24	proposed project and applicable regulations. This
25	permit will enable the facility to construct and

1 operate in compliance with state and federal air 2 quality regulations. The permit includes federally 3 enforceable facility-wide limits to -- to remain below major source thresholds for both the Title V 4 5 operating permit and the prevention of significant deterioration regulations. The limits are less 6 than 250 tons per year of particulate matter and 7 8 less than 100 tons per year of particulate matter 9 emissions, less than ten microns. 10 HEARING OFFICER BLALOCK: Thank you. Now, as we 11 transition into the comment portion of this public 12 hearing, I would like to reiterate that DHEC staff 13 are here to listen to your comments about the 14 proposed Saluda Quarry. Answers or responses to 15 questions will not be provided tonight. All 16 comments made during this hearing are being 17 recorded. If you are unable to complete your 18 comments within the allotted time, you may submit 19 them in writing through the end of the public comment period on Friday, December 15, 2023, by e-20 21 permitting, e-mail, or mail. I will now call on 22 those of you who indicated during preregistration 23 that you would like to make a comment. 24 After I call your name, I would ask that you

come up to the center of the aisle right here

1	because our court reporter has a recorder so we can
2	make sure we get your comments on record. And once
3	you do that, please state and spell your name for
4	the court reporter prior to speaking and state the
5	county in which you live.
6	At this time, we will begin with Jared
7	Matthews. Is that correct?
8	MR. MATTHEWS: My name is Jared Matthews. J-A-R-E-D
9	M-A-T-T-H-E-W-S. I live right next door to this
10	proposed quarry, 4578 Double Bridges Road. I
11	really don't have a problem with rock quarries. I
12	do not have a problem with Luck Luck Quarry
13	company. I do not have a problem with those. I do
14	not have a problem with Vulcan or Martin Marietta.
15	I do not have a problem with quarries themselves.
16	I am very disappointed with the lack of
17	correspondence with the citizens of the surrounding
18	areas such as Saluda, the community from DHEC, and
19	DOT not being here, any company that would have to
20	get permits or would be responsible for answering
21	questions such as the road quality and any other
22	thing. I'm very disappointed with the lack of
23	people being here other than DHEC and the company
24	itself.
25	HEARING OFFICER BLALOCK: Thank you, Mr. Matthews. At

1	this time I would like to call Nelda Rikard.
2	MS. RIKARD: I no longer wish to speak.
3	HEARING OFFICER BLALOCK: Thank you, Ms. Rikard. I will
4	now call Sonya Cary.
5	MS. CARY: I did speak during the public question-and-
6	answer session, so I should you want me to stand
7	up?
8	HEARING OFFICER BLALOCK: Yes, ma'am. Please, if you'll
9	just come to the center of the aisle so we can have
10	the recorder pick up what you're commenting on.
11	MS. CARY: I'm Sonya Cary. I do own Sonya,
12	S-O-N-Y-A, Cary, C-A-R-Y. I do own property within
13	the vicinity here. It is not right next door.
14	It's not that close. I think Mr. Matthews was
15	right. I think if this had not been such a
16	surprise to so many people, it might have been
17	better, a little bit more well received. But,
18	you know, it doesn't seem that there was a lot
19	in place that would require those those
20	comments to the public. But I think that now
21	that you're going to be here, I don't think
22	anybody really wants a mine to be their next
23	door neighbor. So I would think that it would
24	be the responsibility of the mine to invest in
25	the schools, the counties, and to do an awful

1	lot to build public trust and to help these
2	counties benefit from you being here. Not
3	just not just the fact that it's a tax
4	base, but get invested in your counties and
5	your school districts, because that's going to
6	make the difference about how well you are
7	received and what your relationship is going
8	to be.
9	HEARING OFFICER BLALOCK: Thank you, Ms. Cary.
10	MS. CARY: You're welcome.
11	HEARING OFFICER BLALOCK: I would now like to call
12	Michael Boozer. You pass? Okay. Thank you,
13	Mr. Boozer. And Ms. Doris Hicks.
14	MS. HICKS: Thank you. I am Doris Hicks, D-O-R-I-S
15	H-I-C-K-S. I am the pastor of Wesley Chapel
16	Christian Methodist Episcopal Church. And my
17	comments are as follows. I'd like to share with
18	you that the representatives of Luck Stone that I
19	have encountered and met have been friendly and
20	forthcoming with information regarding the company
21	and their intent for Saluda County. Also, I'm
22	impressed with the opportunity that they present to
23	provide jobs for residents here, and I am also
24	looking forward to and impressed with their ability
25	to provide products that our roads may be improved.

1	They also have expressed desire to impact our
2	community in terms of schools and churches, etc.
3	They are my comments.
4	HEARING OFFICER BLALOCK: Thank you, Ms. Hicks. That
5	concludes everyone who preregistered to make a
6	comment. So we will now begin hearing from those
7	of you who did not preregister to speak, but have
8	decided to make a comment. Please raise your hand
9	to indicate that you would like to make a comment.
10	Okay. Well, it looks like I have called on
11	everyone that registered and no one oh, you do?
12	MS. HALLMAN: My name is Katie Coleman K-A-T-T-I-E
13	H-A-L-L-M-A-N. I live in the vicinity of where the
14	quarry will take place. Like Ms. Hicks, I'd like
15	to say I've met with several of the people that
16	work with Luck Companies. I do believe they have a
17	desire to give back to the community. They've
18	already been involved with talking to emergency
19	services, seeing how they can help there, how they
20	can be utilized. And I know there's a lot of
21	they've reached out to find out where in the
22	community things can be bettered. And so I think
23	this is a great opportunity for Saluda County who
24	is in need of having industry come in to take hold
25	of this and just welcome them in and just enjoy



1	having them here. Thank you.
2	HEARING OFFICER BLALOCK: Thank you. Anyone else?
3	Katie, you would like to make a comment?
4	MS. KOSLOSKI: Yes. My name is Katie Kosloski,
5	K-A-T-I-E K-O-S-L-O-S-K-I, and I just wanted to
6	thank DHEC for your time and attention to this
7	matter leading up to this event and tonight, and
8	also wanted to thank each of the members that have
9	taken time to be here tonight. We hear your
10	comments. We look forward to to addressing them
11	in the future and not only meeting, but exceeding
12	your expectations as an operator, as an active and
13	engaged member of the community. Thank you.
14	HEARING OFFICER BLALOCK: Thank you. Anyone else that
15	would like to make to make a comment on the
16	record?
17	Okay. Since there are no other attendees who
18	would like to make a comment, the comment portion
19	of tonight's public hearing is concluded. On
20	behalf of DHEC, I would like to thank everyone for
21	joining us tonight and giving your comments. DHEC
22	will review all comments received by December 15,
23	2023, and may request additional information from
24	the applicant if necessary. A decision will then
25	be made to approve or deny an individual mine

1 operating permit.

2 Once a final permit decision is made, DHEC 3 will provide notification to all who registered or 4 attended this public hearing and all who provided 5 written comments during the public comment period. The final permit decision will also be posted on 6 7 our web page. A summary response to all comments 8 received will be provided if an individual mine 9 permit is approved for this Luck Saluda mine. You 10 have the right to request a final review of any 11 permit decision made by DHEC. The final review 12 request must be submitted in writing to DHEC's 13 Clerk of the Board, along with a filing fee in the 14 amount of \$100 within 15 days after notice of 15 DHEC's permit decision has been mailed. In 16 consideration of this requirement, you will receive notification of DHEC's permit decision by standard 17 18 US mail or by e-mail. If you wish to be notified 19 of DHEC's decision by certified mail instead, 20 please make your request in writing no later than 21 December 15, 2023. 22 Finally, if you have questions or if you are 23 interested in discussing specific aspects of the Luke Saluda mine -- Luck Saluda mine, please reach 24 25 out to Sarah Harris at 803-898-3887 or Mareesa
