Vulcan Construction Materials, LLC has applied to DHEC for a permit to mine limestone at a site located on Addidas Road in Orangeburg County, approximately 3.5 miles southeast of Eutawville, South Carolina (TMS# 0363-00-02-013.000, 0363-00-02-003.000, 0363-00-02-004.000, 0363-00-02-011.000, 0363-00-02-005.000, 0363-00-02-017.000). A proposed reclamation plan to restore the site to grassland and lake/pond has been submitted with the application. The mine permit application and related documents are available for review on DHEC's website at www.scdhec.gov/OrangeburgLimestoneQuarry.

DHEC will hold a **public hearing on** February 8, 2024, at 7:00 PM, to accept oral and written comments on the proposed quarry. A **public meeting will be held from** 6:00 PM until 7:00 PM **prior to the public hearing.** These events will be held at the Eutawville Community Center (419 Porcher Avenue, Eutawville, SC, 29048). Doors will open at 5:30 PM to facilitate the sign-in process and provide an opportunity to meet DHEC staff.

The public meeting is informal and provides an opportunity to have a discussion with the DHEC staff about the quarry and environmental permitting process prior to giving comments at the public hearing. The meeting will begin with a DHEC presentation followed by a time to ask questions.

The public hearing is formal and provides an opportunity to make oral comments that will be heard by DHEC staff and recorded by a court reporter. There will be no questions and answers during the public hearing. DHEC values each participant's involvement in the public hearing and will conduct it in a respectful, orderly manner with reasonable limits on the length of comments, if necessary.
