Notice of Public Hearing and Public Meeting-January 11, 2024

River Bend Aggregates, LLC | River Bend Quarry | Spartanburg County

River Bend Aggregates, LLC has applied to the S.C. Department of Health and Environmental Control (DHEC) for a permit to mine granite at a site located on Hammett Grove Road in Spartanburg County, approximately 2.7 miles northwest of Pacolet. Spartanburg or Cherokee County tax records indicate that you own property next to or within a half-mile of the proposed mine location.

DHEC will hold a **public hearing** on January 11, 2024, at 7:00 PM, to accept oral and written comments on the proposed quarry. A **public meeting will be held from** 6:00 PM until 7:00 PM **prior to the public hearing**. These events will be held at the Benjamin E. Mays Family Center (850 Sunny Acres Rd, Pacolet, SC 29372). Doors will open at 5:30 PM to facilitate the sign-in process and provide an opportunity to meet DHEC staff.

The public meeting is informal and provides an opportunity to have a discussion with DHEC staff about the quarry and environmental permitting process prior to giving comments at the public hearing. The meeting will begin with a DHEC presentation followed by a time to ask questions.

The public hearing is formal and provides an opportunity to make oral comments that will be heard by DHEC staff and recorded by a court reporter. There will be no questions and answers during the public hearing. DHEC values each participant's involvement in the public hearing and will conduct it in a respectful, orderly manner with reasonable limits on the length of comments, if necessary.
