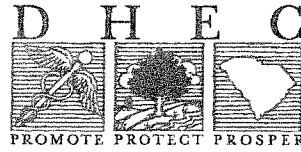

Chairman Amsler asked Mr. Roberts to give an overview of the Requests for Review before the Board for consideration.

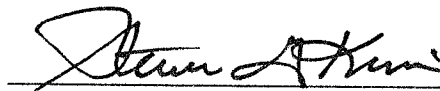

All referenced attachments are made a permanent part of these minutes.

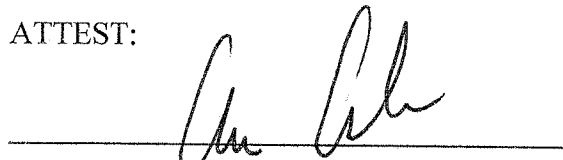
